


NOTICE OF SPECIAL SCHOOL DISTRICT MEETING

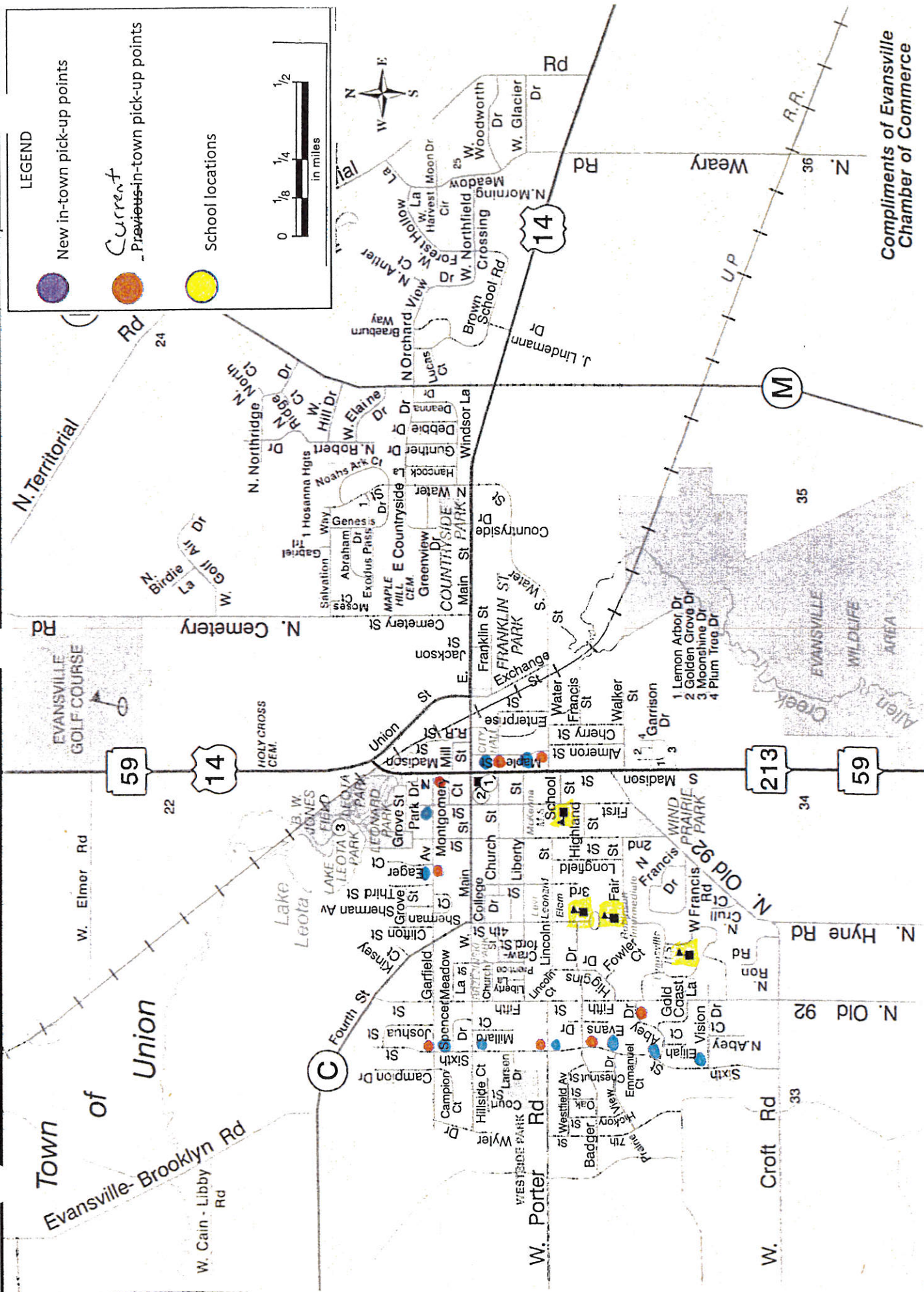

RULES OF PROCEDURE

1. **This is a special meeting**, called upon motion of the School Board, to consider a single subject.
 - (a) That subject is authorizing transportation services from common pick up points, in the morning only, to all students in grades K-8 who reside between 0.5 mile and 2.0 miles from school.
 - (b) No other subject is proper for consideration at this meeting.
2. **Order of Business** will be as set forth in the agenda.
3. **Election of the Chair** is determined by vote of the electors.
 - (a) Nominations from the floor do not require a second.
 - (b) The nominee receiving a majority of votes is elected Chair.
4. **Rules of Debate:**
 - (a) Parliamentary procedures will generally follow Roberts Rules.
 - (b) Please do not speak until recognized by the Chair.
 - (c) When recognized, we ask that you state your name and address.
 - (d) Please keep comments brief and do not speak a second time on an issue until everyone wishing to speak has spoken once.
 - (e) Per Roberts Rules, comments are to be directed to the question at hand, should not attack motives of others, and are to be directed to the Chair.
5. **Voting.** Voting is limited to U.S. citizens age 18 or older who have resided in the School District for at least ten (10) days prior to the date of today's meeting.
