



Question 2: Shall the Evansville Community School District, Dane, Green and Rock Counties, Wisconsin be authorized to issue pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$34,000,000 for the public purpose of paying the cost of a district-wide school building and improvement plan consisting of: construction of a new middle school on the current middle school site and demolition of a majority of the existing building; an addition and renovations for technical education/STEM improvements and roof replacement at the high school; safety, security, building infrastructure and general remodeling improvements at the Grove Campus; district-wide capital maintenance and building infrastructure improvements; and acquisition of furnishings, fixtures and equipment?
